2. School PEN number ( to be collected from previous school).
3. HSLC Admit Card.
4. HSLC Marksheet.
5. School Leaving Certificate/Original Pass Certificate.
6. Caste Certificate (if applicable).
7. Migration Certificate (if applicable).
8. Gap Certificate (if applicable).
9. Domicile Proof (exp. Aadhar/Voter/ Ration Card etc.).
10. Ration Card/ Income Certificate (for the students of **ARTS** Stream seeking fee waiver)
11. Original HSLC Marksheet **without lamination** (for students seeking free admission).

## Guidelines for Fee Waiver/ Free Admission:

1. An income certificate (of income less than Rs. 4 Lakhs per annum) from the local revenue circle officer.  
Or,  
Ration Card issued by the competent authority.
2. Free Admission is only for Domicile State of Assam only.
3. A declaration from the students that neither of the parents (father or mother) of the students is an employee of state/central government, department or its undertaking. If such a declaration is found to be false, the admission shall be cancelled and the admission fee shall be realized from such students.
